- Almost half of middle/high school students participate in Ag.
- 72% of middle school and high school students participate in athletics. All students use the gym for Physical Education.
- The current gym's seating capacity is 400 and often has standing-room only for games/events.

# HOW WAS THE PROPOSAL DEVELOPED?

Representing a cross-section of the community, the district's Facility Advisory Committee met throughout the fall with approximately 30 members. Parents, teachers, staff, and community members all offered unique perspectives as the group worked to identify potential needs.
